

# Art In The Park

## Intent to Participate in the Art In The Park Event

Saturday May 29, 2010 - Starts at 9:00 am - North East Corner of County 4 & 45

### General Information

Registration forms and **\$30 entry fee** should be returned to The Fremont House on or **before April 30**, all entries after April 30 will pay \$40 entry fee. Registration fee is for use of property in parcels of 10' x 10' for the above dates and times. Each parcel will be staked/roped off and mowed and registrants will not exceed the space given for each registered space. Registration fees are non-refundable after April 30, and Art In The Park will not be cancelled for weather conditions, please be prepared for any type of weather - registration refunds will not be made due to weather. If the original registrant cancels and wishes to allow someone else of their choosing to use the space, it must be approved by The Fremont House prior to the space changeover. One crafter per space. Participants may put a 10' x 10' canopy/shelter that must not encroach on spaces on either side of their rented space. This is a family event, we will enforce the dismissal of any participant that is selling inappropriate items for children to view, alcohol drugs or smoking on the premises by participants and those helping with that booth, inappropriate or loud behavior that is disturbing other vendors or homes in the neighborhood. If a registrant is asked to leave for the above reasons, there will be no refund. The Fremont House, Rachel Leonard, and the City of Zimmerman are not responsible for damage or theft to registrants person property, which will include vehicles, trailers, tables,

canopys/tents, for sale items, food, purses, or any personal property that is brought onto the above property during the Art In The Park time listed above. The Fremont House, Rachel Leonard, and the City of Zimmerman are not responsible for any injuries of registrants/members helping registrant, that may occur on the premises while setting up, attending/selling or tearing down the craft day. Generators may be used only with prior permission from organizers of Art in the Park, and must be self contained and out of hearing range for all craft booths and stage performers. Art in the Park is a craft sale-we require that items sold must be uniquely made by the crafter, no resale of premade items (ie: painting/drawings/gift cards by other artists than the registered crafter, premade jewelry, etc. All garments must be embellished by the registered crafter). Crafters may not sell food items other than homemade candies (doesn't include brownies, pies, bars, etc.). The Fremont House reserves the right to deny any crafters that have inappropriate items for our craft venue. We will limit the amount of repeat type items (ie jewelry, rugs, glassware, crocheted/knited items, etc.) so that we represent a wide variety of crafting items for sale. No home party sales may be represented at this craft venue. Please register early to ensure your items are involved in this craft fair.
